The following terms and conditions apply:**

1.) Overview

KCHW 102.7-FM's raffle is a drawing by chance, and void where prohibited or restricted by law. All applicable federal, state, and local laws regulations and ordinances apply. By donating a certain amount, one enters into this game of chance and becomes a Raffle ticket recipient. In doing so, all entrants agree to be fully and unconditionally bound by these official rules and regulations, waive any right to claim ambiguity in the Raffle or these official rules and regulations, and further agree to be bound by the KCHW's decision and interpretations of these official rules and regulations. By entering this Raffle, all entrants release KCHW or any of our respective parent companies or affiliates, directors, officers, employees, and/or agencies from any and all liability.

By entering this raffle, the individual acknowledges that he or she is aware of and is bound by all official raffle rules. Entrants must be legal residents of the United States and 18 years of age or older at the time of purchase.

2.)Eligibility

The KCHW 102.7-FM Raffle is open to residents of the United States, aged 18 years or older at the time of entry, at the time of obtaining the ticket.

The following individuals and immediate family members—defined as spouse, IRS dependent, step or biological mother, father, sister, brother, daughter or son of—or who resides in the same household as, any person in any of the following categories are not eligible to participate:

- Board of Directors for KCHW 102.7FM.
- Any person engaged in development or distribution of Prize supplied for the raffle.
- Any person who resides in an area where this game of chance would otherwise be prohibited by law.

3.) Prize

For the purposes of this raffle, the prize is a 50/50 SPLIT CASH DRAWING FROM TOTAL TICKET SALES

Winners must accept prize “AS IS, WHERE IS, AND WITH ALL FAULTS” with no consideration for return. Income taxes are the responsibility of the winner.

4.) Tickets

Only one eligible person may be entered in the Raffle per ticket, and each entry represents one chance to win. If multiple names are listed on a ticket, the FIRST name will be deemed the holder of the ticket. Division of the Prize, if selected as the Winning Ticket, by a group obtaining a ticket shall be the sole responsibility of the ticket holder as defined above.

Tickets are not transferrable or assignable.

Donations for entries are \$5.00 each. All entries must be paid for in cash.

No refunds are available except where noted; otherwise, all ticket sales are final. Refunds will be made only under the following circumstances with no further liability or recourse:

- If payment for tickets is received after the drawing deadline.
- If the Prize becomes unavailable due to circumstances beyond our control, including fire, storm, theft, damage, etc.

The IRS has taken the position that amounts donated for chances to participate in raffles, lotteries or similar programs are not gifts and, therefore, the price of the entry does not qualify as a deductible charitable contribution for Federal income tax purposes.

5.) Drawing

The random method drawing will take place **at 8:30am on 04/15/19 by a non-interested party live on KCHW FM**

. All ticket sales are final. Winner need not be present to win.

6.) Notification of Winner

The winner will be announced at the drawing **at 8:30am on 04/15/19 by a non-interested party live on KCHW FM**

. Winners need not be present. Winners will be notified via telephone, email or postal mail. Winners will also be announced on KCHW 102.7-FM and on the station's website www.KCHW.org. The winner, by entering the raffle, authorizes KCHW to publish their name, photo and any relevant quotations in promotional material without compensation.

All entrants must produce a valid e-mail address (if applicable), full legal name, home phone number, alternate contact number, physical address, and/or mailing addresses. It is the sole responsibility of the purchaser to provide a valid phone number and deliverable mailing address.

All personal information collected by and during the Raffle will be used for administration of the Raffle. Neither the KCHW 102.7-FM nor any of its affiliates or participating members will share, sell, or otherwise distribute personal information collected for this Raffle except as stated above.

7.) Claim of Prize

Participants do not need to be present at the drawing. If not present, the winning entrant will be notified of his/her winning immediately upon identification verification following the actual drawing via telephone, mail, or email. The holder of the Winning ticket must claim the Prize within 7 days of the drawing.

The Winner will be required to:

- Bring identification by providing a photo ID.
- Bring the winning ticket.
- Complete a W9 and/or other forms as required by law and the IRS for tax withholding purposes.

The Winner assumes all applicable fees and taxes.

In the event the Winner is found ineligible under these rules and regulations, an alternate drawing will be held within five (5) business days of said determination and notification thereof will be posted on the website immediately.
